I Want To Apply. What Do I Do?

First, let's discuss the basic qualifications. You may apply to become a resident of The Tamalpais if you:

- Medically qualify
- Financially qualify
- Manage your own personal and financial matters
- Have Medicare, parts A and B, or the equivalent

Two ways you can choose to apply:

- **Wait List Application:** If you are considering a move in one year or more, this option is recommended.
- **Admissions Application:** If you are considering a move within the year, the full application process is recommended.

What's the difference?

Waitlist Application entails completing a brief, 3-page application form and submitting a \$1,000 deposit per person. The \$1,000 deposit is applied to your Entrance Fee or refunded, if you decide not to apply.

Admissions Application entails completing a more comprehensive packet including a financial report, health care documentation and required lab tests. As part of the admissions process, you will have a pre-entry physical with our Medical Director and an introductory meeting with our Executive Director.

The fee for the Admission Application is \$1,500 per person, \$500 of which is non-refundable.
